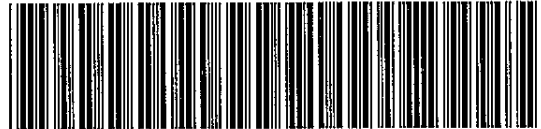

ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a professional limited company under the Florida Limited Liability Company Act, F.S. Chapter 608, and Professional Service Corporations and Limited Liability Companies Act, F.S. Chapter 621, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the professional limited company shall be DAVID B. SIMMONS, P.L. The street address and mailing address of the principal office of the professional limited company in Florida shall be 10200 Avon Park Cut-Off Road, Fort Meade, Florida 33841.

ARTICLE II - DURATION

The professional limited company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State.

ARTICLE III - PURPOSES AND POWERS

The specific purpose for which the professional limited company is organized is to render professional services as a licensed real estate professional in the State of Florida. The general purpose for which the professional limited company is organized is to buy, sell, trade, lease, and to enter into any and all types of agreements related to or pertaining to real or personal property, and to transact any lawful business for which a professional limited company may be organized under the laws of the State of Florida. The professional limited company shall have all

the powers granted to a limited liability company or professional limited company under the laws of the State of Florida.

ARTICLE IV - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the professional limited company in the State of Florida is DAVID B. SIMMONS, 10200 Avon Park Cut-Off Road, Fort Meade, Florida 33841.

ARTICLE V - CAPITAL CONTRIBUTIONS

The members of the professional limited company shall contribute to the capital of the professional limited company the cash or property set forth in Exhibit "A."

ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the professional limited company only upon the unanimous consent of all the members.

ARTICLE VII - ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the professional limited company except with the unanimous written consent of all the members of the professional limited company and upon such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the professional limited company as set forth in the Operating Agreement of the professional limited company, but the transferee shall have no right to participate in the management of the business and affairs of the professional limited company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by

unanimous written consent.

ARTICLE VIII - TERMINATION OF EXISTENCE

The professional limited company shall be dissolved as may be provided in the operating agreement of the professional limited company, or upon unanimous consent of all members.

ARTICLE IX - MANAGEMENT

The professional limited company shall be managed by the member(s) in accordance with the operating agreement which may contain any provisions for the management of the affairs of the professional limited company not inconsistent with law or these Articles of Organization. 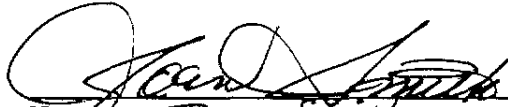
