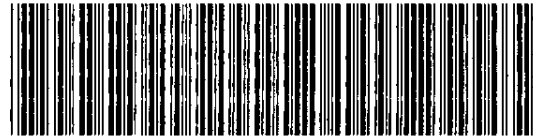




A. Articles of Dissolution shall be prepared and filed.


B. The assets of the company shall be divided between the members in equal shares, the allotment being credited to the liabilities of the company.


C. The company hereby transfers and quit claims to the members in equal shares, the assets of the company.
