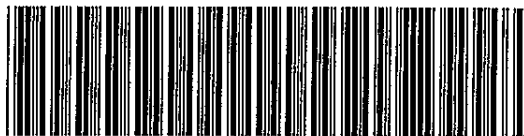


1. Article I of the Articles of Organization of **RBS MACHINE HOLDING, LLC** is hereby amended to read:


