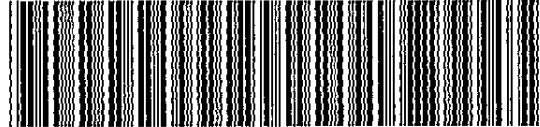

**ARTICLE IV**


The name and address of the registered agent for the Limited Liability Company shall be: CARL EVANS, 501 SE Drane Street, Branford, Florida 32008.

### ACCEPTANCE OF DESIGNATION BY REGISTERED AGENT


