

The name of the initial manager of the Company is Andrew Belford. The address of the manager is 8961 S.E. Bridge Road, Hobe Sound, Florida 33455.

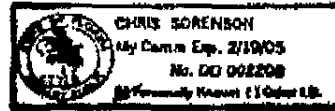
