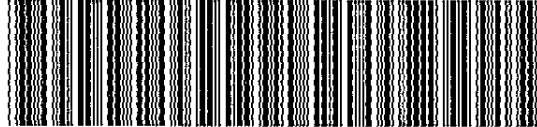

The name of the limited liability company shall be BAR-DEL DEVELOPMENT, LLC ("company").


