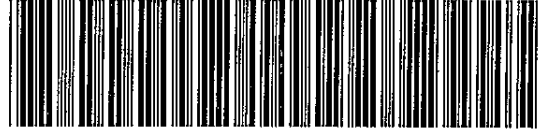

**ARTICLES OF ORGANIZATION OF  
TWO GUYS LAND TRUST, L.L.C.**

**ARTICLE I  
NAME**

The name of this Limited Liability Company shall be: TWO GUYS LAND TRUST, L.L.C.

**ARTICLE II  
PURPOSE**


**ARTICLE VI


