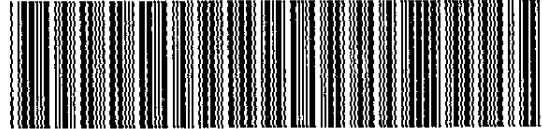

ARTICLE VI - MANAGEMENT


