**ARTICLES OF ORGANIZATION  
OF  
DESTIN COASTAL COLORS, LLC**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida, sets forth the following:

**ARTICLE I - NAME**

The name of this limited liability company is **DESTIN COASTAL COLORS, LLC** (the "Company").

**ARTICLE II - PERIOD OF DURATION**

The period of duration of the Company shall be from the date of filing these Articles with the Department of State until the first to occur of the following:

**ARTICLE VII - MANAGEMENT**

The Company is to be managed by a manager or managers, and is therefore a manager-managed limited liability company. The initial Manager of the Company is JOHN B. KIDD.


