as follows:

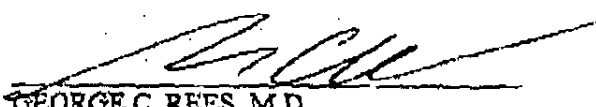
ARTICLE VII - OFFICERS
