ARTICLES OF ORGANIZATION OF KETCHAM CONSTRUCTION COMPANY, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Acet, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization:

Article I - NAME
