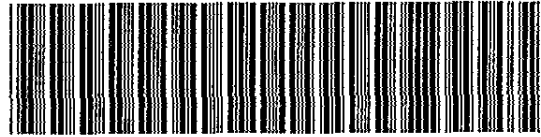

The company may admit additional members at any time and in any manner by the majority written consent of the members.


Article X

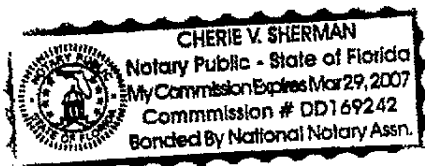
