

ARTICLES OF ORGANIZATION FOR WEST OAKS VILLAGE, L.L.C., a FLORIDA LIMITED LIABILITY COMPANY

Control of the Section of Section 1985 The undersigned member or authorized representative of a member pursuant to Chapter 608 of the Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such Limited Liability Company:
