**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION

A. The name of the limited liability company is Coastal Wave Properties LLC (the "Company").

B. The Articles of Organization of the Company were filed with the Florida Secretary of State on January 30, 2004 and assigned Florida document number L04000008721.

C. The Articles of Organization of the Company are hereby amended and restated in their entirety to read as follows:
