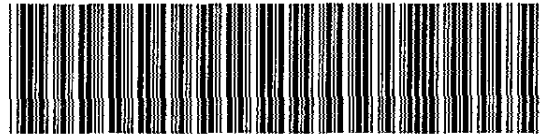

ARTICLE VII- Limitation on Agency Authority of Members:

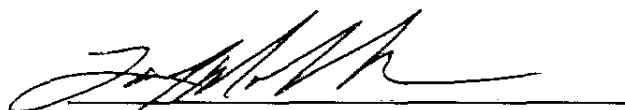

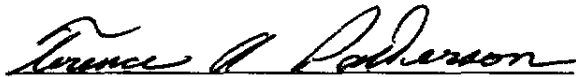

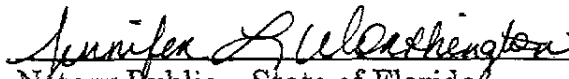
