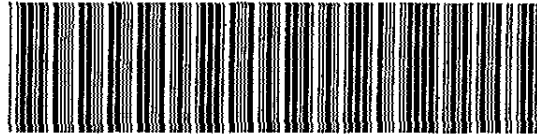

The members shall have the right to admit additional members upon such terms and conditions as set forth in the regulations and the Operating Agreement.

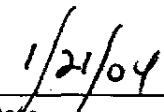
#### ARTICLE VIII – Indemnification
