

ARTICLES OF ORGANIZATION

OF

A Florida Limited Liability Company

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, for the purpose of association to establish a limited liability company for the transaction of business and the promotion and conduct of the objects and purposes hereinafter stated, under the provisions of and subject to the requirements of the laws of the State of Florida, do make, record and file these Articles of Organization in writing.

AND WE DO HEREBY CERTIFY:

FIRST:

The name of the Company is:

PAINT PRESERVATION SPECIALISTS, LLC

SECOND: The principal office and mailing address in the State of Florida is to be located at 13622 Pinecrest Drive, Largo, Florida 33774. The Company may also maintain an office or offices at such other places within or outside the State of Florida, as it may from time to time determine. Company business of every kind and nature may be conducted, and meetings of members may be held outside the State of Florida, the same as in the State of Florida.
