ARTICLES OF ORGANIZATION

ARTICLE I

NAME

ARTICLE IV

REGISTERED AGENT AND OFFICE

ADDITIONAL MEMBERS

The existence of the Company shall commence on the date of filing of the subscription and acknowledgment of the Articles of Organization.

ARTICLE X

POWERS
