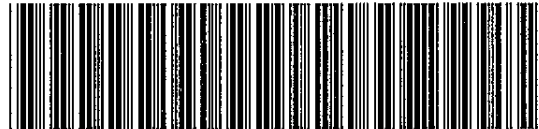

ARTICLE I

NAME

The name of the Limited Liability Company is ENTERTAINMENT UNLIMITED, LLC (the "LLC").

ARTICLE II

MAILING AND STREET ADDRESS

The LLC is to be a member-managed limited liability company.

ARTICLE V
ADMISSION OF NEW MEMBERS

ARTICLE VI
LIMITATION ON AGENCY AUTHORITY OF MEMBERS

Pursuant to Section 608.4227 Liability of members, managing members, and managers.— Except as provided in this chapter, the members, managers, and managing members of a limited liability company are not liable, solely by reason of being a member or serving as a manager or managing member, under a judgment, decree, or order of a court, or in any other manner, for a debt, obligation, or liability of the limited liability company
