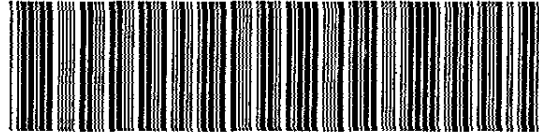



**ARTICLES OF ORGANIZATION  
OF  
DRD REALTY, LLC**

The undersigned hereby forms and establishes a limited liability company under the laws of the State of Florida.

**ARTICLE I**

The name of this limited liability company is DRD REALTY, LLC ("Company").

**ARTICLE II**

The mailing address and street address of the principal place of business of the Company is 600 Dixie Avenue, Ste. 711, Tallahassee, FL 32304. The Company may at its discretion, at any time, change the address of its principal place of business.

**ARTICLE III**
