

ARTICLES OF ORGANIZATION

OF

MD PAINTING, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Figrida Limited Liability Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I - NAME


