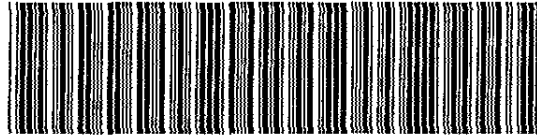

FOR

ARTICLE I - Name

The name of this limited liability company shall be CROLE, LLC.

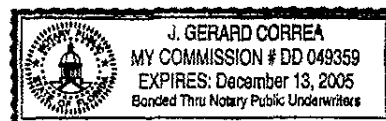


