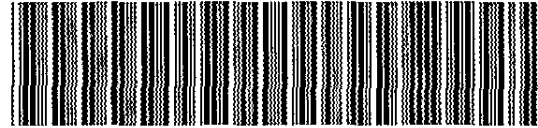



The name of the limited liability company shall be Design Plus Enterprises, LLC.


ARTICLE 2: PURPOSE
