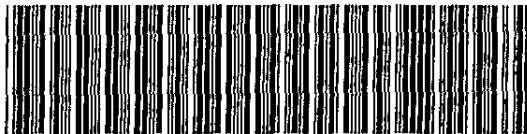

The name of the limited liability company is Institute of Wealth Management, LLC




The existence of the Organization shall be no longer than 30 years.
