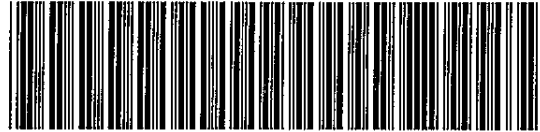

ARTICLES OF ORGANIZATION

The Company may indemnify any manager, member, officer, employee or agent of the Company to the fullest extent permitted by Florida law.


