OF  
PREMIER AMERICAN RESTAURANTS #3, LLC**

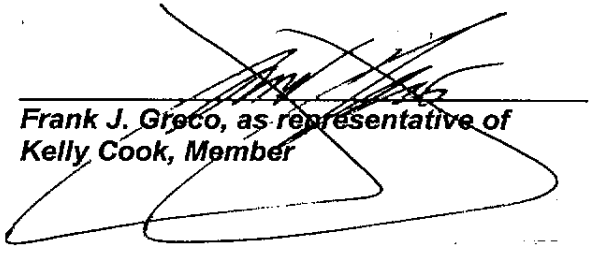
These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

1. Name. The name of this limited liability company is **PREMIER AMERICAN RESTAURANTS #3, LLC** ("Company").
2. Duration. The Company shall exist from the date hereon until the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.
3. Mailing Address and Street Address. The Company's mailing address is **15110 Arbor Hollow Drive, Odessa, Florida 33556**. The Company's street address is **179 1<sup>st</sup> Avenue North, St. Petersburg, Florida**.
4. Registered Agent and Office. The name of the initial registered agent of the Company is **Frank J. Greco, Esquire**. The street address of the initial registered agent of the company is **4047 Henderson Boulevard, Tampa, Florida 33629**.
5. Additional Members. Additional members to the Company may be admitted, but only if all the current members agree to the admission of the additional members and to the terms of admission.
6. Termination of Membership. If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, by unanimous consent, continue the business of the Company.
7. Management of the Company. The Company shall initially be managed by **Kelly Cook** who shall serve as manager until the first annual meeting of the members or until his successors are elected and qualify:

9. Date of Existence of the Company. The existence of the Company shall commence on the date hereof.

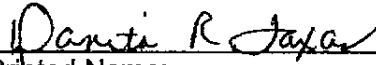

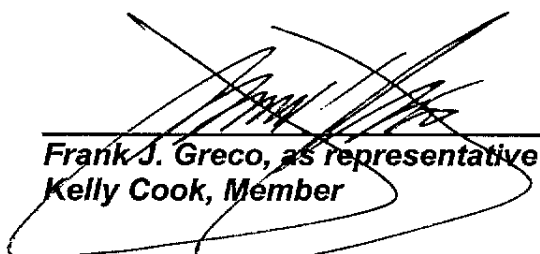
