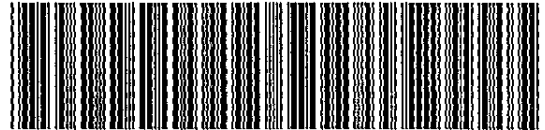

as a Member with authorization to sign documents on behalf of Line 13 Properties, LLC.


At this time Debra Meyer is to be removed as a Member of the LLC.
