## ARTICLES OF ORGANIZATION JECARPER ENTERPRISES, LLC

MARCH S PARCOS STATIONS The undersigned, a natural person over the age of eighteen years, acting as the Organizer of a Limited Liability Company under the Florida Limited Liability Company Act, adopt the following Articles of Organization:
