**ARTICLES OF ORGANIZATION  
OF  
CRSJMR CONSULTING L.L.C.**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes ( the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

**1. NAME**

The name of the Limited Liability Company is CRSJMR Consulting, L.L.C.  
(hereinafter referred to as the "Company").

**2. PERIOD OF DURATION.**

The period of duration of the Company shall not exceed the maximum term permitted under the Florida Limited Liability Company act. The Company may be dissolved sooner, however as provided in the Florida Limited Liability act or the written Operating Agreement to be executed by all the Members of the Company.

**3. PURPOSE**

The purpose of which the Company is organized is to purchase, own, sell, mortgage, and do everything incidental or necessary relating to real property and personal property, including farming, timber farming, development, and to engage in any and all other businesses and activities permitted by the laws of the State of Florida. **9. MANAGEMENT**

The Company shall be managed by the Member(s).

**10. INDEMNIFICATION**

Unless expressly agreed otherwise in writing by all of the Members, the Company shall indemnify any Member or former Member to the full extent permitted under the Florida Limited Liability act.

**11. EFFECTIVE TIME**
