ARTICLES OF ORGANIZATION OF DAL, LLC

EFFECTIVE DATE

- 1. NAME. The name of this limited liability company is DAL, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
- 2. PLACE OF BUSINESS. The street address of the Company's principal office is 4304 Roland Street, Tampa, Florida 33609. The mailing address for the Company is 1611 W. Platt Street, Tampa, Florida 33606.

- 5. OPERATING AGREEMENT. The manager or managers shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
