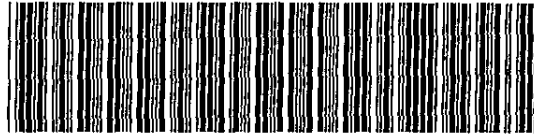



The name of the limited liability company shall be D³:Data Driven Decisions, LLC.


ARTICLE II. PRINCIPAL PLACE OF BUSINESS



