The name of this limited liability company is 1235 NW 54<sup>TH</sup> STREET, LLC (hereinafter the "Company").

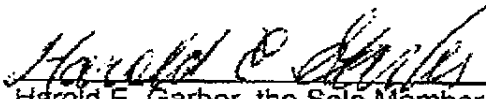
