ARTICLES OF ORGANIZATION

OF

RICHARD L. LUTE, JR., L.L.C.

ARTICLE I - NAME:

The name of the Limited Liability Company is RICHARD L. LUTE, JR., L.L.C.

ARTICLE II. PERMITTED BUSINESSES

AND ACTIVITIES

This limited liability company may engage in every phase of any and all activities or businesses permitted by the laws of the United States and the State of Florida or any other state, territory, district or possession of the United States and all such activities or businesses as may be permitted in any foreign country. Without limiting the generality of the foregoing, the limited liability company shall have power to:

- Guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge (e) otherwise dispose of the shares of the capital stock of, or any bonds, securities or other evidence indebtedness created by any corporation of this state or any other state or government and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.
- Contract debts and borrow money, issue and sell or pledge bonds, debentures, (f) notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property or other instruments, to secure the payment of corporate indebtedness as required.
 - Make gifts for educational, scientific or charitable purposes. (g)
- Indemnify any person made a party, or threatened to be made a party, to any (h) threatened, pending or completed action, suit or proceeding, against liability for their good faith acts and omissions to the extent provided by law.
- Purchase and maintain insurance on behalf of any person who is or was a (i) member, manager, employee, or agent of the corporation, or is or was serving at the request of the limited liability company as a member, manager, officer, director, employee, or agent of another corporation, partnership, joint venture, trust, or other enterprise, against liability asserted against him and incurred by him in any such capacity or arising out of his status as such, whether or not the limited liability company would have the power to indemnify him against such liability under the other provisions of these Articles.
- Enter into general partnerships, limited partnerships (whether the limited **(i)** liability company be a limited or general partner), joint ventures, syndicates, pools, associations, and other arrangements for carrying on one or more of the purposes set forth in these Articles, jointly or

in common with others, so long as the participating corporation, person or association would have power to do so alone.

The foregoing clauses are both purposes and powers, and the foregoing enumeration of specific powers does not limit or restrict in any manner the powers of the limited liability company.

ARTICLE III. TERM OF EXISTENCE

The existence of this limited liability company is to begin upon the date of subsorbers of these Articles and shall continue perpetually thereafter.

ARTICLE IV. PRINCIPAL OFFICE ADDRESS
