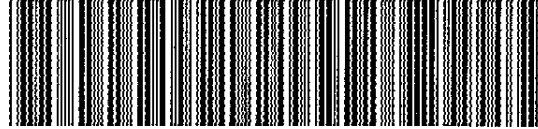

The name of the limited liability company shall be Tim's Pressure Washing, LLC ("company").


