ARTICLES OF ORGANIZATION FOR MURIEL REAL ESTATE, LLC

Article 1

The name of the limited liability company is Muriel Real Estate, LLC ("Company"). The Company is hereby empowered to engage in all business and activities lawful under the laws of the United States of America and the State of Florida.

- (c) Upon the death, retirement, resignation, expulsion, bankruptcy, dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, unless the business of the Company is continued by the consent of the remaining Member(s) and there is at least one remaining Member of the Company.
