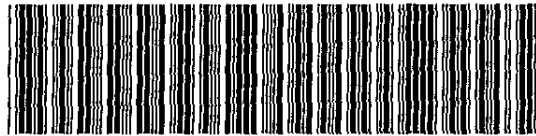

ARTICLES OF ORGANIZATION

TLC LAWN CARE, LLC

The undersigned subscriber hereby forms a limited liability company under the laws of the State of Florida, Florida Statutes, Chapter 608 as follows:

ARTICLE I

NAME

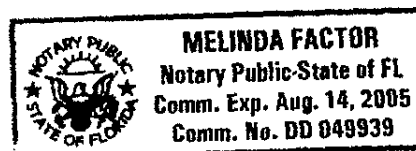
