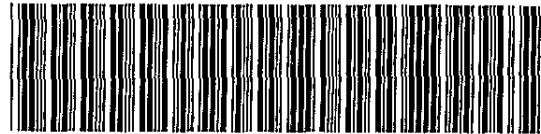

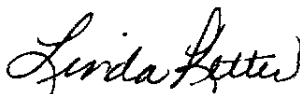

**ARTICLES OF ORGANIZATION
OF
JACS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - Name

The name of the Limited Liability Company is: **JACS, LLC.**

ARTICLE II - Address

ARTICLE V - Additional Members

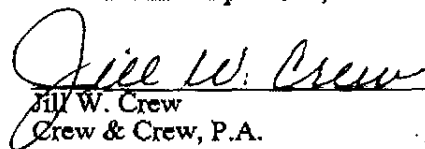
