## ARTICLES OF ORGANIZATION

#### OF

## LANE AVENUE INDUSTRIAL PARK, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization:

#### **ARTICLE I**

#### Name

The name of the limited liability company shall be LANE AVENUE INDUSTRIAL PARK. LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 537 Lane Avenue, Jacksonville, Florida 32254.

## **ARTICLE II**

#### Duration

## ARTICLE III

#### **Purposes and Powers**
