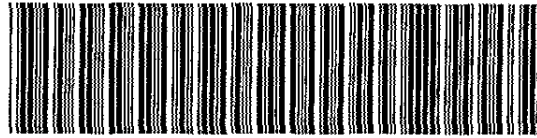

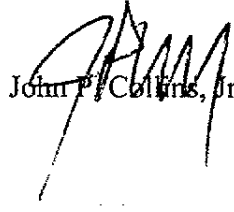

The name of the limited liability company shall be B&B Enterprises of Lakeland, LLC ("company").

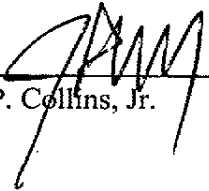
