ARTICLES OF AMENDMENT TO  
ARTICLES OF ORGANIZATION  
BAY AREA PHYSICIAN'S SURGERY CENTER, LLC

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of Bay Area Physician's Surgery Center, LLC, a Florida limited liability company (the "Company"), are hereby amended as follows:
