ARTICLES OF ORGANIZATION OF ADAMS CASSIDY, LLC

ARTICLE I - NAME

The name of this Limited Liability Company is ADAMS CASSIDY, LLC.

ARTICLE II - ADDRESS AND PRINCIPAL PLACE OF BUSINESS


