ARTICLES OF ORGANIZATION
OF**

The Articles of Organization for this limited liability company were filed on February 16, 2004, and assigned Florida document number L04000012615.

This amendment is submitted to completely amend and restate the Articles of Organization for this limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as follows:

ARTICLE I - NAME

The name of the limited liability company shall be Water's Edge of Bradenton, LLC (the "Company").

ARTICLE II - ADDRESS

The mailing address and initial principal office of the Company shall be 2335 North Bank Drive, Columbus, Ohio 43220. The principal street address of the Company is 2015 32nd Avenue West, Bradenton, Florida 34205.

ARTICLE III - DURATION

The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Company's Operating Agreement.

ARTICLE IV - REGISTERED OFFICE AND AGENT


