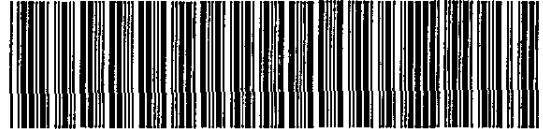

## ARTICLES OF ORGANIZATION

OF

**ROBERT M. JOHNSON, P.L.**

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608 and a professional service company under the Professional Service Corporations Act Chapter 621, hereby makes, acknowledges, and files the following Articles of Organization.

### ARTICLE I - NAME

The name of the Limited Liability Company and professional service company shall be **ROBERT M. JOHNSON, P.L.**, the "Company". The mailing address and street address of the Company in Florida shall be 27 South Orange Avenue, Suite Two, Sarasota, FL 34236.

### ARTICLE II - DURATION

The Company shall commence its existence on March 1, 2004. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization.

### ARTICLE III - PURPOSES AND POWERS

The general purpose for which the Company is organized is to engage in the profession of practicing law and to transact any lawful business for which a Limited Liability Company and professional service company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a Limited Liability Company and professional service company under the laws of the State of Florida.

### ARTICLE IV - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the State of Florida is Robert M. Johnson, 350 Golden Gate Point, #43, Sarasota, Florida 34236.

### ARTICLE V - ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the written consent of the sole member of the Company and upon such terms and conditions as shall be determined by the sole member. A member may transfer his or her interest in the Company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

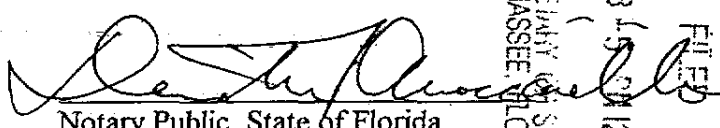

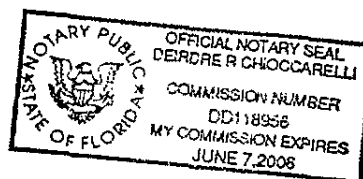
