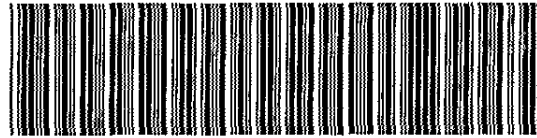


ARTICLE IV - MANAGEMENT


