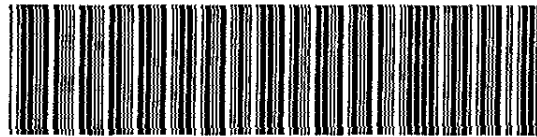

**ARTICLE I  
NAME OF LIMITED LIABILITY COMPANY**

1.01 NAME.-- The name of this limited liability company shall be M & A AUTOMOTIVE LLC.

**ARTICLE II  
GENERAL NATURE OF BUSINESS**




