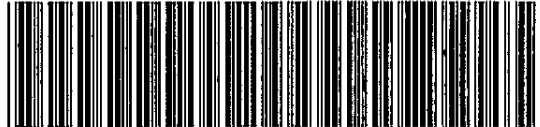



**AMENDED AND RESTATED ARTICLES OF ORGANIZATION  
OF  
JAYS BUILDING MAINTENANCE & CLEANING, LLC**

Pursuant to the Florida Limited Liability Company Act the undersigned, acting as organizer of a limited liability company, hereby adopts the following Amended and Restated Articles of Organization for such Company:

**FIRST:** The date of filing the articles of organization was February 17, 2004.

**SECOND:** The following amendments to the articles of organization were adopted by the limited liability company.

**ARTICLE I  
NAME OF LIMITED LIABILITY COMPANY**

The name of the Limited Liability Company was JAYS BUILDING MAINTENANCE & CLEANING, LLC and should be changed to **S&J'S FASHION, LLC**.

**ARTICLE II  
OFFICE AND MAILING ADDRESS**

The principal office of **S&J'S FASHION, LLC** (hereinafter referred to as "Company") in the State of Florida will be located at 2620 North Hiawasse Road, Orlando, Florida 32818. The mailing address is Post Office Box 829, Clarcona, Florida 32710. The Company may have other offices within the state of Florida, as the Members may designate or as the business of the Company may require. The registered office of the Company required by the Florida Limited Liability Act to be maintained in the state of Florida may be, but need not be, identical with the principal office, and may be changed from time to time by the Member.

**ARTICLE III  
PURPOSE**

The Company shall be formed for any and all lawful purposes and shall have unlimited power to engage in and do any lawful act concerning any and all lawful businesses for which companies may be organized un the Florida Limited Liability Company Act. In connection with the above mentioned purposes, the Company shall have the power to invest its funds in real property and securities, to acquire, own, and dispose of real property, and do all other acts incident and necessary to the accomplishment of the foregoing purposes, to the extent permitted under the Florida Limited Liability Company.
