AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF JAYS BUILDING MAINTENANCE & CLEANING, LLC

Pursuant to the Florida Limited Liability Company Act the undersigned, acting as organizer of a limited liability company, hereby adopts the following Amended and Restated Articles of Organization for such Company:

FIRST:

The date of filing the articles of organization was February 17, 2004.

SECOND: The following amendments to the articles of organization were adopted by the limited liability company.

ARTICLE I NAME OF LIMITED LIABILITY COMPANY

The name of the Limited Liability Company was JAYS BUILDING MAINTENANCE: & CLEANING, LLC and should be changed to **S&J'S FASHION**, **LLC**.

ARTICLEII OFFICE AND MAILING ADDRESS
