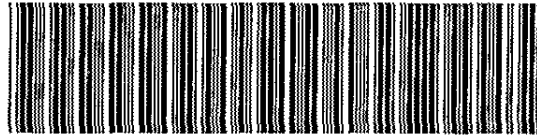

**ARTICLES OF ORGANIZATION OF
CKM ADVISORS, LLC**

The undersigned, desiring to form a Limited Liability Company under and pursuant to §608.405, Florida Statutes, does hereby certify as follows:

- FIRST:** The name of said limited liability company shall be CKM ADVISORS, LLC.
- SECOND:** CKM ADVISORS, LLC shall exist in perpetuity.
- THIRD:** Copies of the Operating Agreement of CKM ADVISORS, LLC may be obtained from the Manager at 1140 San Pedro Avenue, Coral Gables, Florida 33156 which is the place in the State of Florida where the principal office of the limited liability company is located. 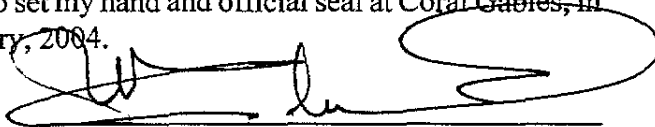

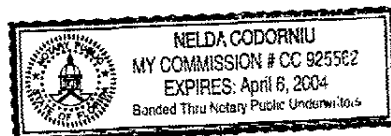
