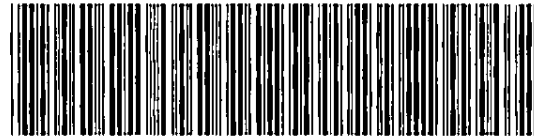

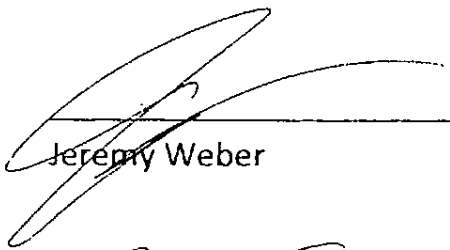

The company will remove Jeremy Weber from any obligation and hold him harmless for future lawsuits with All American Purification, LLC.

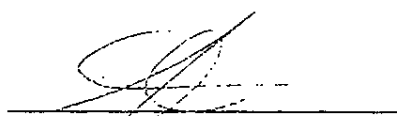

The Partnership Notice of Withdrawal will be filed with the Secretary of State on this date September 18, 2018.

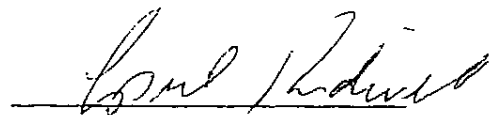

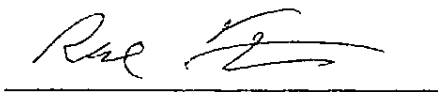

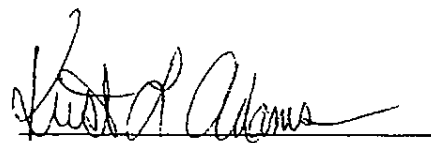
