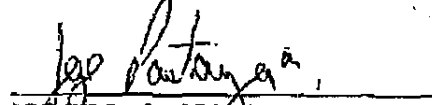

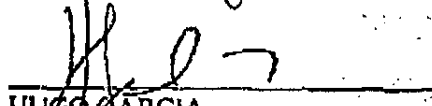
There are no ongoing and/or pending lawsuits, claims and/or liens against the Company and/or any of its assets in any court.

The effective date of the Company's dissolution shall be 14 day of March, 2007.

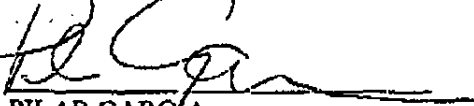

SUNSET GROUP INVESTORS, LLC (the "Company")

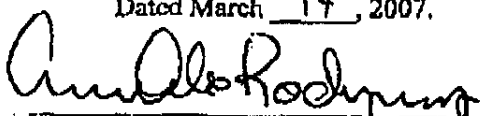
WHEREAS, on March 14, 2007, the Company held a duly noticed meeting; and

WHEREAS, all members were present at the meeting; and

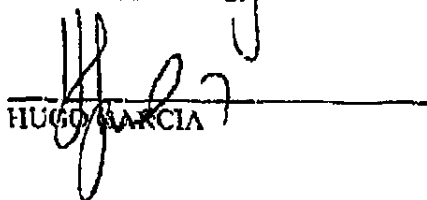
WHEREAS, a vote was taken and the members unanimously approved and resolved as follows:

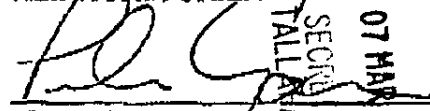
